Annex I Practical English courses. Undergraduate studies.

Students of the 2nd and 3rd year may be exempted from attending Practical English courses on the basis of the successfully passed C1 examination in English organised exclusively by the Institute of English Studies (IoES). **No exemption is available from the courses Academic Writing I and II**. Applications must be addressed to the Institute Coordinator of Practical English Teaching after the examination grades appear in the USOS in June (IoES does not hold C1 examinations in the winter session). Students who pass the examination in September may apply for exemption only in the academic year following the one starting in October. Applications must be submitted each year by the date announced. Students may apply for exemption from all the PE courses at a given year of study or only some of them, by which they declare that they wish to enrol in the remaining ones. Exemptions are not granted automatically for two years. If no application is submitted, it is understood as a declaration to participate in the PE courses. The application is complete with an enclosed USOS print-out showing the C1 examination grade. The PE courses in which students have enrolled must be completed.

1a. Students exempted from the PE courses on the basis of the C1 examination results are granted ETCS for all the courses required by the Study Programme. The C1 examination grade is entered in the USOS documentation next to each PE course in the relevant semester.

1b. PE courses develop a range of skills tested in the C1 examination but they are not meant to practise examination-type techniques and tasks. The Institute Coordinator of Practical English Teaching does not decide on the form and content of the C1 examination.

Students are obliged to attend three PE courses (six hours) a week.

Graduate studies

I year students are obliged to complete CLIL Academic Writing (two hrs a week) in **one** semester and CLIL Academic Speaking (two hrs a week) in **the other**.

I year weekend students enrol in two semesters of CLIL Academic Writing (two hrs a week).
